Preliminary Consideration:

- Faced with a bug for lower/upper case in email. Solved inside Zenodo...lost some time!
- Lost the ownership of the files already uploaded (except the Stefano's Slides), that have been deleted.
- Now things look stable.

OpenAccessRepository.it (2)

Site philosophy:

Community is not made of people, is made of things, in this sense the name repository is correct!

Everybody can subscribe to the site (see how to do in next slides) and upload any kind of things...
...that **MUST be related to at least one Community**.

Everybody can also create his/her own community (if approved by the site manager), but of course this is not the correct way to use the site.

When a file is uploaded the Community curator (they decided to use the name for people normally responsible of museum!!!) receive an email to approve the upload, object uploaded by INFN people are also sent, by default, to the INFN Community curated by Roberto Barbera.

A Community called **Cygno Project** has been created, and as consequence curated, by me.

Every object get a DOI (Digital Object Identifier).

Four different status are possible for an object: Open, Closed, Restricted, Embargoed.

Start operating in OpenAccessRepository.it

Before to start any operation is better to define a link with this account and your Orcid and Github account.

This is well described in the OAR user guide: https://www.openaccessrepository.it/record/30458#.Xx5z5_gzaqA

In page 6-8 is described how to connect the two accounts then (pages 9-12) how to sync.

Similar procedure (for the connection) is foreseen for Orcid.

In the same guide you also find how to upload files, the procedure is simple but many things are important to be present and correctly defined:

- Community
- Type of file (paper, talk, software...)
- Author (better if with Orcid!)
- Keywords (one word/row)
- Access Right : Open, Embargoed, Restricted, Closed
- European Support : Initium (easy using the drop-down choice)

Preliminary Conclusions on using OpenAccessRepository.it

Access Right explanation:

- Open: Free for everybody
- Embargoed: The Product is protected for a certain period (decided by the owner) then became Open
- Restricted: The product is protected, but is foreseen to ask the owner to get access (for a certain time or forever).
- Closed: The product is visible to the owner only...and to the OAR administrator...the Curator??? (I ask!!!)

Anyway...all products are always visible as title and owner. The protection is on the contents!

To start to get experience with the site I upload the files of the three talks done at RD-51 CM.
These files have been cancelled because of the “case” bug.

I would like to invite Davide, Francesco and Giorgio to do by themselves this upload being the owners of the talk...and I want to invite all cygnoers to upload talks they have done in the past.

This is useful also to test the chain...I should receive the approval request...these files are in principle public (are present in the CM Indico Agenda) and therefore I think should be Open!

In the future we will decide how to define the right access...for different situations.
